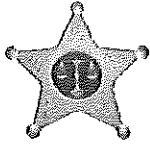

INTERGOVERNMENTAL AGREEMENT BY AND AMONG

**THE COUNTY OF UNION, ILLINOIS,
THE CITY OF ANNA, ILLINOIS,
THE CITY OF JONESBORO, ILLINOIS,
THE VILLAGE OF ALTO PASS, ILLINOIS,
THE VILLAGE OF COBDEN, ILLINOIS
AND
THE VILLAGE OF DONGOLA, ILLINOIS**

**RELATING TO THE FUNDING OF THE
UNION COUNTY DRUG TASK FORCE**

THIS INTERGOVERNMENTAL AGREEMENT is made as of May 1, 2012 (the "Effective Date"), by and among the County of Union, Illinois, a body politic and corporate, ("Union County"), the City of Anna, Illinois, ("Anna"), the City of Jonesboro, Illinois ("Jonesboro"), the Village of Alto Pass, Illinois ("Alto Pass"), the Village of Cobden, Illinois ("Cobden") and the Village of Dongola, Illinois ("Dongola", and together with Union County, Anna, Jonesboro, Alto Pass and Cobden, the "Parties").

WHEREAS, pursuant to Article VII, Section 10 of the Illinois Constitution of 1970, and 5 ILCS 220/1, *et seq.*, the Parties are authorized to enter into an intergovernmental agreement;

WHEREAS, the Parties find it is in the best interest of the residents of Union County, Anna, Jonesboro, Alto Pass, Cobden and Dongola to curtail the unlawful sale and distribution of drugs and other controlled substances in Union County; and

WHEREAS, the Union County Sheriff has established a Union County Drug Task Force; and

WHEREAS, Anna, Jonesboro, Alto Pass, Cobden and Dongola desire to assist Union County in funding the Union County Drug Task Force.

NOW, THEREFORE, in consideration of the foregoing recitals and the mutual covenants and promise contained herein, the sufficiency of which is hereby acknowledged, the Parties hereby agree as follows:

(1) The Parties shall fund the Union County Drug Task Force according to the attached Exhibit "A". Payments made under this Agreement shall be due on July 1, 2012 and shall be paid to the Union County Treasurer.

(2) The Chiefs of Police of Anna, Jonesboro, Cobden and Dongola and the Union County Sheriff shall be kept apprised of the activities of the Union County Drug Task Force in

their respective jurisdictions. The Union County Sheriff shall also act as the representative of Alto Pass regarding the activities of the Union County Drug Task Force.

(3) The Parties shall undertake reasonable efforts to make law enforcement personnel employed by the Parties available to assist the Union County Drug Task Force.

(4) The term of this Agreement shall be from the Effective Date through April 30, 2013.

(5) If any provision of this Agreement is held to be invalid, illegal or unenforceable, the validity, legality and enforceability of the remaining provision shall not be affected.

(6) This Agreement, including the rights, benefits and duties hereunder, shall not be assignable by any Party without the written consent of the Parties.

(7) The Parties may execute this Agreement in counterparts, each of which is deemed an original and all of which only constitute one original.

IN WITNESS WHEREOF, the Parties have executed this Agreement as of the date and year written above.


