Please consider this our response to the attached January 27, 2015 Freedom of Information Act request for the following summarized items:

- A. *Tape of a conversation with an officer on June 12, 2014.*
- B. *Name of the bailiff on duty with Judge Thurston on June 11, 2014.*
- C. *Length of time Lorraine Moreland has been in office as the Union County Circuit Clerk.*
- D. *Number of threats she has received in that time.*
- E. *Procedures for dealing with such threats.*
- F. *The person alleging to be threatened on June 12, 2014 and the time.*
- G. *The name of the clerk who was in court with Judge Thurston on June 11, 2014.*
- H. *Length of time Tyler Edmonds has been in office as the Union County State's Attorney.*
- I. *Number of times he has ordered defendants be assessed for fitness to stand trial.*
- J. *Number of those individuals found unfit to stand trial.*
- K. *Number of times Tyler Edmonds has used Ken Donaldson.*
- L. *Number of times Tyler Edmonds has utilized the services of Patrick Duffy.*

Regarding (C), Lorraine Moreland was appointed as Union County Circuit Clerk in 1995 and was elected to that office in 1996 and has filled that office since that time.

Regarding (D), (E), (I), (J), (K) and (L) we have no record responsive to your request.

Regarding (H), Tyler Edmonds was elected in 2008 and has served as Union County State's Attorney since 2008.

Regarding (A), (B), (F) and (G), we are denying your request for these records as they are potentially related to your pending trial in case number 2014CF120. Mr. Edmonds has spoken to your attorney, Mr. Baril, regarding this matter and we are copying him on this response. Should Mr. Baril determine that any of these records are needed for your defense, he may obtain them through discovery.

Also regarding (A), (B), (F) and (G) and pursuant to Section 9(a) of FOIA (5 ILCS 140/9(a)), please note the following:

- (1) We are denying these records because this is a pending case and disclosure would interfere with a pending law enforcement investigation and create a substantial likelihood that a person will be deprived of a fair trial or an impartial hearing pursuant to Section 7(1)(d)(i) of FOIA (5 ILCS 140/7(1)(d)(i)) and Section 7(1)(d)(iii) of FOIA (5 ILCS 140/7(1)(d)(iii)).
- (2) Chief Information Officer Rollie Hawk and State's Attorney Tyler Edmonds are the persons responsible for this denial.
- (3) You have the right to review by the Public Access Counselor. Her contact information is below.




