To Whom It May Concern:

I hereby request, in accordance with the [Illinois Freedom of Information Act](#) (5 ILCS 140), an electronic copy of your government's annual payroll records. Your response should include, but not be limited to, the following information:

Employee names, ID numbers, titles, departments, annual salaries, and start-dates for every employee in every department of your government, salaried or hourly.

Please note I am not asking for annual salary to date from the start of the calendar year or fiscal year, but rather *what each individual's current annual salary is*. For hourly employees, please provide that hourly rate. Finally, please include salary data for any and all elected officials on your payroll, salaried or hourly.

If I have reached you in a particular department of your government entity, please note that we want records for your entire government payroll, not just the department where you work.

Also, Illinois FOIA law requires you must respond to this request ***within five business days after you receive this request***. Our preference is to receive this material by email in Microsoft Excel format, though we can also process this data in an Access Database or a comma/tab separated text file. Please email this information to ***LHolton@bettergov.org***.

If this information can't be emailed in any of the above spreadsheet formats, the BGA can arrange to pick up this data on CDs or other media, or you can mail this material directly to: Lisa Holton c/o The Better Government Association, 223 W. Jackson, Suite #900, Chicago, IL 60606.
