

Victim Damage To Property Administratively Closed on 7/25/2015

On 07/25/2015 I Deputy Jeffrey Stroehlein UC31 was dispatched to ██████████ in reference to property damage. The caller, ██████████ informed dispatch that her ex boyfriend Jeff Wyatt had come to retrieve his belongings from the house and had broken down the door. She told dispatch that he had only taken his items but had left in a gold Jeep Grand Cherokee and was headed toward Carbondale. I drove to the Union/Jackson County line on US 51 North and did not see the above mentioned vehicle so I then went to the residence at ██████████

Upon my arrival I observed tire marks in the gravel where it appeared someone left in a hurry, see attached photograph. I then was met at the front door by ██████████ I observed damage to the inside of the door frame which I photographed and attached to this report. ██████████ was very upset but told me that she had told her ex boyfriend Jeff Wyatt had come to retrieve his property because he had been living there part time. She said she had set his belongings on the porch but he said there was more in the house. She told me that they had a verbal confrontation and she became scared so she went in the house and locked the door. At this time he yelled through the door that he still had laundry and food which she got for him and took it to a side door. He then demanded his laundry detergent and bleach along with some of his other food items from the freezer. She said that he then broke down the front door and she got scared so she locked herself in her bedroom while he retrieved the rest of his items from the freezer then left. I asked her if Jeff took anything that belonged to her and she said no. I then gave ██████████ a voluntary statement to fill out which she did. As I returned from my squad with a non traffic citation for her to sign. As I presented it to her and informed her that he would be charged with criminal damage to property she said she would not proceed with charges because she did not want him to have any further trouble. I again asked her if she wished to proceed with charges and she said no that she just wanted to document the incident but did not want him to be arrested or charged. I asked her to add that to her voluntary statement which she did. I took her statement and exited the property.

I have attached the voluntary statement and photographs to this report. I have nothing further to report at this time.
