Defend the Vote is conducting voter integrity and election security investigations in every voting district in Illinois. Our objective is to assure that federal and state election laws are properly followed and that security protocols set up to protect the vote are in place and in use.

Defend the Vote will utilize a variety of methods in this investigation. These methods include FOIA, poll watchers, audit related scoring, and reviewing data. We will report this information through our public website, www.DefendtheVote.com.
