Mr. Godfrey:

Please consider this our response to your attached Freedom of Information Act request, received via email on July 28, 2016 and summarized below:

Any and all police reports with reference to Jessie Lee Bell, Jessie Bell, Jessie L. Bell.

[Please note that request was dated June 28, 2016 but was received on July 28, 2016.]

We appreciate your agreeing to grant us extended time to complete our response. Per our phone discussion on August 4, 2016, I have limited the scope of this response to (a) only reports where Mr. Bell is involved as a suspect and not as a witness and (b) only initial reports.

Please find attached records responsive to your request with the following redactions made:

- Driver's license numbers, social security numbers, personal telephone numbers, home addresses and personal license plates have been redacted pursuant to Section 7(1)b of FOIA (5 ILCS 140/7(1)b) as they are private information as defined in Section 2(c-5) of FOIA (5 ILCS 140/2(c-5)).
- Dates of birth have been redacted as that information is exempt under Section 7(1)(c) of FOIA (5 ILCS 140/7(1)(c)) as approved by the Office of the Attorney General in pre-authorization letter 2011 PAC 13577.
- The names of third parties who were never arrested or were incidentally mentioned in police reports are exempted under Section 7(1)(c) of FOIA (5 ILCS 140/7(1)(c)) as approved by the Office of the Attorney General in pre-authorization letter 2011 PAC 12140.
- We feel that photographs of a deceased victim are not in the public interest per Section 7(1)(c) of FOIA (5 ILCS 140/7(1)(c)), therefore those portions are exempt from release. Per pre-authorization letter 2010 PAC 11939, the Office of the Attorney General approved application of the Section 7(1)(c) exemption regarding the release of "postmortem photographs" and determined that doing such "would constitute a clearly unwarranted invasion of personal privacy."

We are denying a number of records that involve a juvenile. Pursuant to Section 9(a) of FOIA (5 ILCS 140/9(a)), please note the following:

- (1) We are denying these records per Section 7(1)(a) of FOIA (5 ILCS 140/7(1)(a)) as the Juvenile Court Act (705 ILCS 405) requires that all police reports be withheld if they involve the arrest, charging or investigation of a minor.
- (2) Chief Information Officer Rollie Hawk and State's Attorney Tyler Edmonds are the persons responsible for this denial.
- (3) You have the right to review by the Public Access Counselor. Her contact information is below.





During the conversation, [REDACTED] made a statement, that had not previously been disclosed.

At approximately 1:42 p.m., I spoke with [REDACTED] in the conference room, located in the front of the States Attorney's Office. People in the room were myself, States Attorney Tyler Edmonds, Assistant States Attorney Heather Heaslett, and [REDACTED]

[REDACTED] told me a fight had taken place, between Jessie Bell, and James Morrison. After the fight, [REDACTED] and [REDACTED] had gotten into a regular cab pickup truck, to leave the house. [REDACTED] was driving the truck, and [REDACTED] was sitting in the middle. Jessie Bell had gotten in the truck, on the passenger side. Before [REDACTED] could drive off, Jessie got back out of the truck. As Jessie was getting out of the truck, Jessie said "I'm not gonna let him live", Jessie went to where James Morrison was laying. James was laying face down, on the concrete, on the back porch. Jessie used his left hand, and grabbed James by the hair, on the back of James' head. Jessie started hitting James in the back of the head. Near the end of this fight, Jessie removed his shirt.

On Tuesday, May 6, 2014, at approximately 9:05 A.M., Carla Harvel, Sheriff's Deputy (Telecommunicator/Jailer) with the Union County Sheriff's Office informed me, Scott Harvel, Chief Deputy with the Union County Sheriff's Office, that detainee Jessie Bell needed to speak with someone regarding his current court case. Jessie indicated that someone else was involved in the incident that nobody was aware of and he needed to tell someone. For additional information, see memorandum prepared by Deputy C. Harvel maintained in this case file.

Subsequently, I contacted Scott Rice, Chief of Police, with the City of Anna, and relayed the aforementioned information to him.

Chief Deputy Scott Harvel

I Deputy Josh Kelley # 6177, on 06/05/14 at approximately 1355 hrs while performing my duties as a telecommunicator for the Union County Sheriff's Office, overheard some inmates being loud so I stepped out in the hallway and overheard [REDACTED] (DOB [REDACTED]) who was in holding cell #3 state, "He was a piece of shit, he should be in the fuckin' ground." The inmates had been talking for awhile and we were trying to work so I intervened and told them to quit yelling between cells.

I informed Chief Deputy Scott Harvel of what I had overheard. Chief Deputy Harvel told me to go back to the video surveillance and document the conversation.

I then listened to the conversation on the video surveillance at the Union County Sheriff's Office. In the video surveillance Bell who was in holding cell #2 stated to another inmate "You know what I'm going to do to you boy, I'm going to beat your fucking brains in." While reviewing the audio recording you can hear another inmate ask Bell, "How many times he whoop you before?" Bell stated "That bitch did not whip me one time.....cause bitch is in the ground dead....that's where that bitch is." After coming into the hallway and telling the inmates to lower their voices and going back into dispatch, the inmates continued to have a conversation Bell stated, "Dude came and got his ass whooped, and if I gotta do the rest of my life...over something like that...then I guess I got to." Later on in the reviewed discussion Bell states, "I hit the man with my fists, I don't have to have a weapon." After reviewing the conversation, I believe Bell was speaking about the murder of James Morrison. I have attached DVD copies of the conversation between [REDACTED] and Bell to this report.

I contacted union county sheriffs office dispatch. I asked dispatch, did you receive any calls, in reference to what had taken place at [REDACTED]? I was told someone called 9-1-1. The call came from phone number [REDACTED]. The person that called 9-1-1, did not say anything, and hung the phone up. Dispatch called the number back, and did not get an answer. The system showed the call was coming from the area of [REDACTED]. Within just a few seconds, I arrived at [REDACTED], so dispatch did not try to call the number again.

Investigators, and Crime Scene Investigators, from the Illinois State Police arrived at [REDACTED]. At approximately 7:05 a.m., I left.

Deputy Robert McGee

On 04/12/2014 at 0519 hours, I Deputy Jeffrey Stroehlein UC31 was contacted by Deputy Robert McGee UC14. Deputy McGee informed me that I needed to contact Chief Scott Rice of the Anna Police Department in reference to a homicide investigation they were conducting with the Illinois State Police. After speaking with Chief Rice, he asked me to go to the scene and assist securing the scene and also assist in the neighborhood canvass when special agents from the Illinois State Police arrived. I arrived at the crime scene, [REDACTED] in Anna, IL and maintained scene security until agents from the Illinois State Police arrived.

Special Agents McDaniel and Cooper arrived on scene and I assisted them with the neighborhood canvass. See Special Agent Cooper's report for further details. After a search warrant was obtained, CSI (Crime Scene Investigator) Sutton and other Special Agents executed said search warrant and collected evidence from the scene.

At approximately 1230 hours, I went to the Union County Sheriff's Office and gathered the clothing that was being worn by [REDACTED] who was in custody for a failure to appear warrant as evidence. Turner signed the evidence receipt and changed out of his clothing and I took his clothing as evidence. I took the evidence that was retrieved and signed it over to the Illinois State Police for the duration of the investigation.

I later assisted Special Agent Barr with interviews at the Union County Sheriff's Office of [REDACTED] and [REDACTED]. [REDACTED] residence was where Bell was taken into custody by the Illinois State Police and Taylor was the person who called in Jessie Bell's location and was also present during the apprehension of Jessie Bell. There were two large, outdoor trash cans, close to James. One trash can was blue. One trash can was green. After I took the photographs, I moved the trash cans, so the EMT's would have more room to work.

An ambulance from the Union County Ambulance Service arrived. The EMT's were Michael E. Akers, and Julian P. Lopez.


Lopez and Akers, started CPR. Officer Smith and I, assisted in getting James onto the gurney, and into the ambulance. James was transported to the Union County Hospital.





Bell was then handcuffed and placed under arrest for Domestic Battery. Bell was then transported to Tri-County by Sgt. Stamp.

I then spoke with [REDACTED] and [REDACTED] on the incident. [REDACTED] advised that Bell had been drinking all night and came home highly intoxicated at approximately 4:30AM. [REDACTED] then said that they started arguing and that Bell was accusing her of cheating on him. [REDACTED] then said that during the argument he hit her in the face with his fist. There was no bruising but the left side her [REDACTED]'s face was very red. [REDACTED] advised that she was a witness to all of the incident.

When asked, [REDACTED] did not want any medical attention. I then advised her that on Monday

she needed to go the Domestic Violence Building in Jonesboro and talk to them about the incident. I then advised both [REDACTED] and [REDACTED] that if they had any questions to contact me at the Union Count Sheriff's Department.

I officer John Theriac was dispatched to the Union County Sheriffs Department to speak to [REDACTED] in reference to a battery that occurred on Friday, July 26, 2002 on Heacock St. in Jonesboro. [REDACTED] stated that Jessie Bell hit him in the mouth and threw a brick at a vehicle owned by Harris Auto Sale in Jonesboro. The vehicle, a 1995 Toyota Paseo was being test driven by [REDACTED]. Estimate and vehicle information attached. At 6:30 p.m. Union County Sheriffs Department received a call that Jessie Bell was at the John St. housing. Myself and Union County Sheriff's Deputy David Johnston went to John St. housing. Upon arrival, [REDACTED] met us and said that Bell had just left. Deputy Johnston and myself then went to [REDACTED] to see if Bell was there. When we arrived, Bell was there. I asked Bell to step over towards the car, Bell asked "what do you want?" I told him that I needed to talk to him told him to go to the car and place his hands on the car. He refused. I asked him if he wanted to do this the hard way and he flexed his arms and stated yes. I then told Bell he was under arrest for Battery and Criminal Damage to Property. Bell stated "I'm not going anywhere". Bell took one step towards me then turned and ran towards the Jonesboro Square up the hill. Deputy Johnston and myself radioed dispatch to advise of the situation. Anna Police Officer Bart Hileman informed us that he was on his way to assist. Bell ran up the hill towards Mayberry Music. Myself and Deputy Johnston observed Bell run back behind Charter Communications. Officer Hileman arrived and turned on Pecon by Mayberry Music. Myself and Deputy Johnston then started going through the woods looking for Bell. At 6:50 p.m. Myself and Deputy Johnston got into my patrol car to see if Bell was heading back to John St. housing. When we got on N. Main, myself and Deputy Johnston observed Bell on a bicycle cutting across Heacock off of N. Main. I got in behind Bell then pulled up beside Bell. Bell fell over in the ditch. As Deputy Johnston exited the squad car, Bell got up and came towards Deputy Johnston. Deputy Johnston used his O.C. spray on Bell. Myself and Deputy Johnston then put Bell on the ground and hand cuffed him. I then transported Bell to Union County Sheriff's Department for booking. Deputy Johnston decontaminated Bell with the water hose before he was taken inside. No further incident occurred. Bell is out on Mandatory Supervisory Release from Illinois Department of Corrections. His parole was revoked pending outcome of charges.

On 02-01-2014 at approximately 2110 hours I spoke with [REDACTED] at the Anna Police Department via telephone. [REDACTED] called the Anna Police Department in reference to a Domestic Battery. When [REDACTED] called I answered the phone. [REDACTED] stated that Jessie Bell was at her house and that she needed Police there. I asked [REDACTED] if she could tell me what it was in reference to. [REDACTED] stated that Jessie had come to her house looking for her daughter, and then stated that he was now putting his hands on her and to "please hurry".

I informed other Anna Police Officer's Josh Schildknecht and Mike Hunter that we had a possible Domestic Battery in progress and immediately left the Office for [REDACTED]'s location. On the Phone [REDACTED] stated that she was at [REDACTED]. I arrived and was directed by a family member that all parties involved were at [REDACTED], which is [REDACTED]'s Apartment located next to [REDACTED]. I would later learn that [REDACTED] is where [REDACTED] and Jessie Bell reside. As I approached the residence I could see a male subject standing in the doorway who I recognized to be Jessie Bell. Jessie was pointing towards someone inside the residence and yelling at them.


I advised Jessie to step outside of the residence. I could see two females on the other side of him. One who I recognized as [REDACTED]. The other female I would later identify as [REDACTED]. I observed that [REDACTED] had redness on the left side of her face and her cheek appeared puffy. I again advised Jessie to step outside as to separate the parties. Jessie came out towards myself and Officer Schildknecht raising his arms, and yelling at us. Jessie was stating things such as "what", "what the fuck did I do", "why are you here", "I didn't do a damn thing". Jessie continued to display an aggressive behavior towards us. I instructed Jessie to place his hands behind his back, and that he was going to be detained until I could determine what was going on here. Jessie began raising his arms and again making statements that he didn't do a thing, and this was bullshit. Jessie stepped towards me so I unholstered my Taser and again instructed Jessie to place his hands behind his back. Officer Hunter then approached from the side and I believe when Jessie saw Officer Hunter he realized there were 3 Officers there and finally complied. Jessie was handcuffed and placed in a patrol car.

I entered the residence at [REDACTED] and spoke with [REDACTED] and [REDACTED]. I asked [REDACTED] just to verify, that she was the person I spoke with on the phone and she stated yes. I asked her to explain to me what had occurred. [REDACTED] advised that she had been at home when her grandson came over telling her that Jessie had ahold of [REDACTED] and that they were fighting. [REDACTED] stated that [REDACTED] is her daughter. [REDACTED] stated that she went next door to where her daughter lives at [REDACTED]. [REDACTED] stated that Jessie was yelling at [REDACTED]. [REDACTED] stated that she had [REDACTED] leave and come over to her house at [REDACTED]. [REDACTED] advised that they did

come back to her house but that Jessie just followed them over. [REDACTED] stated that Jessie was yelling at [REDACTED] and telling her that she was going to leave with him and that he grabbed her, and that's when she called for Police.

I asked [REDACTED] if Jessie had put his hands on her, or hit her. [REDACTED] stated that Jessie had put his hands on her but he had not hit her. I asked [REDACTED] what happened. [REDACTED] stated that Jessie had came home and that she told Jessie while he was gone that his Uncle had stopped by. [REDACTED] stated that when she did, Jessie began accusing her of sleeping with his Uncle and became angry with her. [REDACTED] stated that at one point Jessie had grabbed her face and described it as Jessie placing his hand on her face and squeezing her mouth together, while yelling at her. [REDACTED] indicated that Jessie had only been out of Prison for about a week and that he had been drinking the last two days. [REDACTED] stated that Jessie gets like this every time he drinks. [REDACTED] stated that she did not want to press charges against Jessie but that she did not want to be around him. I advised [REDACTED] that I was going to place Jessie under arrest for Domestic Battery and informed her that the State can file charges in Domestic Battery cases without a complaint from the victim. I advised [REDACTED] that I felt if this action were not taken that Jessie may return at a later time tonight where he would be in a more agitated state and possibly do more harm to her. [REDACTED] stated that she thought I may be right.

I then left and Jessie Bell was transported to the Union County Sheriff's Office where he was processed and issued two citations. One for Domestic Battery and one for Resisting or Obstruction a Peace Officer.

On Tuesday April 01, 2014, at approximately 10:15 AM, I Officer Bryan Watkins, was contacted by Chief Scott Rice. He gave me information in reference to a person in violation of a court ordered bond condition. Chief Rice told me he received information from Sheri Vega, who is the victim's advocate employed by the Union County States Attorney's Office, saying Jessie Bell was staying at [REDACTED], Anna, IL. This address is a protected address listed in a bond condition stemming from a domestic violence incident that occurred on February 01, 2014.

The order of condition of bond stated Jessie Bell was to have no contact, directly or indirectly, with the domestic violence victim [REDACTED]. It also stated Bell was not to come within 500 feet of the victim's residence of [REDACTED], Anna, IL. This order was signed on February 03, 2014, by Judge Mark Boie, in the Circuit Court of the First Judicial Circuit, in Union County, IL.

At approximately 10:50 AM, Chief Rice and I drove to [REDACTED] to speak with Bell. I knocked on the front door while Chief Rice stood alongside the house to make sure no one exited from another door. I knocked on the door for approximately 5 minutes and no one answered. While standing on the front porch, a neighbor called out to Chief Rice and I. We walked over to where the neighbors were standing, and they told us if we were looking for Jessie, he had just left. We were told Jessie and [REDACTED] had left the residence and were driving a brown colored four door car. Chief Rice gathered a little more information from the neighbors, while I relayed the vehicle information to other patrol units in the neighborhood. Chief Rice and I then left the residence.

At approximately 1:30 PM, Chief Rice received information that Bell had returned to [REDACTED]. He and I drove back to the residence to try and make contact with him. I contacted the Union County Sheriff's Department to have one of their patrol units meet with us, in case Bell would try to run. I knocked on the door and I heard a male voice on the other side asking who it was at the door. I identified myself as a police officer. I could see a male subject peering through a window glass located at the top of the door. I was able to identify that male subject as Jessie Bell. Bell opened the door and I explained to him why the police were at his the residence. I told Bell I had received information that he was staying at the residence and there was a bond condition stating he was not to be at the residence. Bell told me he was never notified about the bond condition, or he would have stayed away. Chief Rice called the states attorney's office and he was told Bell was notified in court on February 03, 2014, about the condition of bond. I took Bell into custody without incident. He was handcuffed and the handcuffs were checked for proper fit and double locked.

I transported Bell to the Union County Sheriff's Department for processing. While at the sheriff's department, I escorted Bell into cell number two. I gathered my handcuffs and shut the cell door, leaving Bell in the custody of the Union County Sheriff's Department.






