**Victim Assault Pending Investigation**

On 09/09/2014 I Deputy Jeffrey Stroehlein UC31 received a phone call from Terry Hamel at the Union County Sheriff's Office regarding a property dispute. Terry told me that he had retrieved his father's lawnmower to mow at his father's residence. He said that he had to go to town to get oil for the mower and when he returned to his house, his aunt [REDACTED] aka [REDACTED] had taken the mower back to his father's residence located at [REDACTED] which is next door to his residence. He said that was not an issue but when he went to get it back and put oil in it, his Aunt started yelling at him and the two had a, "Cussing match." Terry said he only wanted his aunt to stay off of his property and he would be happy.

Later that afternoon I received a call from [REDACTED]. [REDACTED] stated that the previous day she had left her brother and sister in law's residence to go to town and when she returned, her sister told her that she had got the mower back from Terry's house and did some mowing. She said that the mowing was done and she and her sister in law were having a cup of coffee outside when Terry came to the property line and began cursing at his mother telling her she was, "a no good whore and a thief." [REDACTED] said that Terry then turned his aggression toward her and told her that he would go into his father's home, get one of his guns and, "blow your fucking head off!" [REDACTED] said that Terry then left and there was no further incident but [REDACTED] stated to me on the phone that she did fear for her safety when she was at her brother's house. [REDACTED] also said that she did not wish to file a charge against him but she wanted us to be aware of the situation. [REDACTED] said in closing that Terry had also gone on a rant a few days prior stating that if anyone moved into his father's house after he died, he would burn the house down.

I have nothing further to report at this time.
