Please consider this our response to your attached February 1, 2016 Freedom of Information Act request, summarized below:

I am seeking documents related to the number of and names of the Union County employees who are union members with the name of their affiliated union and residential zip codes.

Please find enclosed records responsive to your request for employee names and union affiliations with the following redactions made:

- Social security numbers are defined as personal information in Section 2(c-5) of FOIA (5 ILCS 140/2(c-5)) and per Section 7(1)(b) of FOIA (5 ILCS 140/7(1)(b)) are exempted.
- We feel our Paychex account number is technical information associated with automated data processing and that to disclose such information would jeopardize the security of the Paychex system and as such under Section 7(1)(o) of FOIA (5 ILCS 140/7(1)(o)) is exempted.

We are denying the portion of your request involving employee ZIP codes. As such, please be advised of the following:

- (1) We are denying your request for employee ZIP codes as approved by the Office of the Attorney General in pre-authorization letters 2010 PAC 8615 and 2010 PAC 9808.
- (2) Chief Information Officer Rollie Hawk and State's Attorney Tyler Edmonds are the persons responsible for this denial.


