Please consider this our response to your attached Freedom of Information Act request, received via postal mail by Union County Chief Information Officer Rollie Hawk on February 7, 2017 and summarized below:

I am requesting records sufficient to show the Union County Sheriffs Office's policy on immigration detainers, including but not limited to any written policy or Sheriff's Office memos describing the office's practice upon receiving detainer requests (U.S. Department of Homeland Security form 1-247). The policy should show whether or not the Union County Sheriff's Office complies with Immigration and Customs Enforcement requests to detain inmates (who have been arrested on local charges) in the Union County jail on behalf of the federal agency, and whether or not the Union County Sheriff's Office complies with ICE requests to notify the federal agency of an inmate's release date.

Per Union County Sheriff Scott Harvel, his office has no policies or memos of the type requested. As such, we are in neither the custody nor the possession of records responsive to your request.
