DETAILS OF OFFENSE

ON December 28, 2016 I was assigned to security in Court room #2. At 1:00 p.m or shortly after Judge Lambert entered Court Rm #2 and Attorney Kruger was present representing Mr. Carraker. Attorney Kruger asked to be removed as Attorney off record. Also present in Courtroom #2 was Attorney Schneider & Attorney Burger. Judge Lambert signed a paper releasing Attorney Kruger. This reporting person received a call on court phone and was informed Attorney Karraker was on his way but running late. I'm not sure what time but Attorney Karraker arrived with his wife. Judge Lambert spoke with Attorneys present and left courtroom. After Judge Lambert left courtroom Mrs. Karraker came from courtroom seating area and pass out some papers to Attorney Schneider & Burger. After receiving papers Attorney Schneider requested to have Judge Lambert return to courtroom. This reporting person went into chambers and spoke to Judge Lambert about Attorney Schneider's request. AS told by ~~Attorney~~ ^{Judge} Lambert I informed Attorney's still in courtroom that was it for the day. There was some loud talking by Attorney's present but I'm not sure what was said. I escorted Attorney's from courtroom with no incident.
