**R/P Motor Veh Anti-Theft Laws Pending Investigation**

On 06/30/17 at approximately 8:00 A.M., I, Deputy J. Schildknecht responded to [REDACTED] for the report of a stolen tractor.

Upon arrival I met with [REDACTED] and [REDACTED] the owners of the tractor. [REDACTED] stated he used the tractor last night and parked it just before dark at [REDACTED], and when he returned this morning at 7:15, the tractor was gone.

[REDACTED] described the tractor as 1997 or 98 International Model 5240. Serial # JJF1058223 with approximately 500 hours. He also stated the tractor had front wheel assist, a loader with a hay fork, a ditcher on the back and a baler monitor in the cab.

I obtained a written statement from [REDACTED] (see statement attached).

At approximately 2:40 P.M. the tractor was recovered on Hwy 127 S just north of County Line Rd. I spoke with [REDACTED] and [REDACTED] they agreed they would like the tractor processed by ISP Crime Scene. I then contacted Rod's towing and had the tractor towed to the Union County Sheriff's impound lot.

Upon arrival at the impound lot, I asked T/C Benefield to contact ISP Crime Scene, and advise them I had a tractor for them to process. On 07/03/17 I spoke to CSI Turner. She advised me she would be processing the tractor for me. I have attached CD-R provided by CSI Turner.
