On 07/02/2017 I Sergeant Jeffrey Stroehlein UC31 responded to a call in reference to a two car accident at State Route 3 North near the intersection at Dyno Nobel. Upon my arrival, I spoke with [REDACTED] who stated he was driving north on State Route 3 and a white pick up driven by Richard Ring pulled out in front of him. He said to avoid a collision, he exited the roadway and was able to come to a stop in a field. He said his vehicle had no damages and his daughter, [REDACTED] had a minor injury to her arm possibly from trying to better restrain her daughter, [REDACTED] was later transported via ambulance.

I then spoke with Mr Ring who said he looked both ways and let two cars pass by and he was blinded by the sun but did not see [REDACTED] coming so he pulled out to go south. He came back to check on [REDACTED] and both he and [REDACTED] were understanding to the fact it was not intentional.

I took their information for this report and did not issue any citations.
