Please consider this our response to your attached October 28, 2015 Freedom of Information Act request, summarized below:

*Police report involving an altercation at the Revlon Tavern, 7965 STATE HWY 146, Jonesboro, IL on 7/18/15 involving XXXXXXXXXXXX and suspect Brad Gregory.*

Please find attached the requested report with the following redactions:

- The names of the victims have been redacted as they are exempted under Section 7(1)(c) of FOIA (5 ILCS 140/7(1)(c)) as approved by the Office of the Attorney General in pre-authorization letter 2011 PAC 12171.
- Dates of birth have been redacted as that information is exempt under Section 7(1)(c) of FOIA (5 ILCS 140/7(1)(c)) as approved by the Office of the Attorney General in pre-authorization letter 2011 PAC 13577.
- Home addresses, personal telephone numbers, driver's license numbers and personal license plate numbers are defined as personal information in Section 2(c-5) of FOIA (5 ILCS 140/2(c-5)) and per Section 7(1)(b) of FOIA (5 ILCS 140/7(1)(b)) are exempted.
- Pages regarding medical information and medical treatment are redacted as they are exempt under Section 7(1)(c) of FOIA (5 ILCS 140/7(1)(c)) as approved by the Office of the Attorney General in pre-authorization letter 2010 PAC 6834. In further accordance with 2010 PAC 6834 this response will be treated as a partial denial.
- Names of witnesses are exempted under 5 ILCS 140/7(1)(c) as approved by the Office of the Attorney General in pre-authorization letter 2011 PAC 15997.

In accordance with 2010 PAC 6834 and given that multiple pages have been redacted in whole, we are treating this response as a partial denial. As such, please be advised of the following:



**Suspect Aggravated Assault Pending Investigation**

Report for Incident 2015-002655, Investigation. On 07/18/2015 at approximately 1830 hrs, a call was placed to the Union County Sheriff's Office reporting an incident that occurred at the Revlon Bar, which is located in Union County Illinois. The call was being placed by a Staff member of South East Hospital in Cape Girardeau Missouri.

The reporting staff member (nurse) stated that it is Hospital policy to report any incident that seems to be suspicious. The Patients name reported was [REDACTED]. [REDACTED] entered the hospital seeking treatment for a cut to his hand by a pocket knife. [REDACTED] stated to Hospital Staff that he was cut while attempting to remove an irate individual while inside of the Revlon in Ware Illinois.

At approximately 2058 hrs, this R/O arrived at the Revlon. This R/O was met outside the bar by a man who was identified as [REDACTED] of East Cape Illinois. [REDACTED] stated that he was a Finance Manager for the Lone Star Saloon in East Cape, and also helped with the Revlon. This R/O asked [REDACTED] what had transpired. [REDACTED] stated that a man named Brad Gregory had a knife in the Parking Lot and a guy got cut. According to [REDACTED] it was all an accident.

At this time [REDACTED] of Jonesboro Illinois came outside from the bar. [REDACTED] stated that he wanted to press charges on Gregory for pulling a knife on him and threatening to "slit his throat" while inside of the bar. I asked [REDACTED] if he would be willing to fill out a statement on what had transpired. This R/O then asked [REDACTED] if the bar had working video surveillance. [REDACTED] stated that it did, but then stated that everything happened outside not in the bar. [REDACTED] then spoke up and said " [REDACTED] the guy pulled the knife inside the bar". This R/O then asked [REDACTED] to continue filling out his statement.

It was stated to [REDACTED] that the video needed to be reviewed to check for anything that may be significant to the incident. It was later found that [REDACTED] is actually related to the Gregory subject, and it was also stated that [REDACTED] is the person who had the knife that was used in the incident. Neither of the facts were stated to this R/O from [REDACTED]

This R/O was then approached by [REDACTED] who had finished his statement. This R/O asked [REDACTED] to explain what had happened. [REDACTED] stated that he was in the bar talking to the bartender and a gentleman named Brad pulled a knife on him and threatened to "cut his throat". [REDACTED] stated he was sitting there minding his own business and did not say a word to the guy. It was then found out that a bartender by the name of [REDACTED] also went to the Hospital for unknown injuries connected to the incident.

Two days later, this R/O stopped at the Revlon to see about getting video footage. This R/O was directed to a female by the name of [REDACTED] who works for the Pony in East Cape Illinois. Contact was made with [REDACTED] [REDACTED] was informed that video was needed from the Revlon for 7/18/2015 between the times of 6:15 pm and 7:45 pm. [REDACTED] stated she would attempt to get that taken care of.

Supplemental Report for Incident 2015-002655, Investigation. On 7/21/2015 at approximately 1900 hrs, [REDACTED] arrived at the Union County Sheriff's Office. It was noticed that [REDACTED] had her left hand in a medical device. [REDACTED] stated that she was the bartender working at the Revlon when the reported incident took place. She stated that after the incident she had to go to the Hospital because of her hand. This R/O asked [REDACTED] to explain what had transpired.

[REDACTED] stated that she was at the end of the bar speaking with [REDACTED] Gregory began yelling at [REDACTED] Doss said that Bradley continued talking to her and ignored Gregory. Gregory then became very irritated and was cursing at [REDACTED] According to [REDACTED], [REDACTED] at that point turned to Gregory and stated " dude I don't what you are talking about" then turned back to Doss.

[REDACTED] said that is when Gregory stated he was going to Kill [REDACTED] [REDACTED] then again said he did not know what Gregory was talking about, or know what your problem is. Gregory then made the statement " I should just cut your throat" talking to [REDACTED] Then Gregory stated he was "Special Forces" and should just kill you, I should just gut you (meaning [REDACTED]).

[REDACTED] stated that is when Gregory pulled a knife out and stated he was going to Slit [REDACTED]'s throat. That is the point where [REDACTED] grabbed Gregory. [REDACTED] stated that she came over the bar and also grabbed Gregory and was attempting to remove him from inside of the bar. [REDACTED] stated that when [REDACTED] was attempting to pull Gregory outside, is when he ([REDACTED]) was cut on his hand with the knife. [REDACTED] said the whole time Gregory was being pulled outside, he was still yelling at [REDACTED] that he was going to slit his throat.

█████ stated that during the process of pulling Gregory outside, Gregory grabbed her index finger of her left hand with his left hand which is also the hand Gregory had the knife in. She stated at that point she attempted to get the knife from his hand. Gregory then pulled her index finger backward and twisted her wrist.

█████ said that once Gregory was outside of the bar, they were able to calm him a little by saying he was making his wife scared. ██████ said that ██████ then decided to leave the bar with his wife ██████ and a friend ██████. Gregory attempted to chase them into the road. ██████ stated that once ██████ was gone, they got the bleeding stopped from ██████'s wound, and went to the Hospital in Missouri. Once ██████ and ██████ were treated, she said they went back to the bar to finish her shift. ██████ filled out a voluntary statement on the incident.

Statement: I [Redacted] was working at the Reuban on Saturday July 18th when Brad started yelling at [Redacted]. Now everything got started. [Redacted] and I were at the end of the bar talking when Brad was on the side of the bar and started yelling at [Redacted]. [Redacted] continued talking to me while Brad became very irritated and yelling and cursing louder. Finally [Redacted] said dude I don't know what you are talking about, then turned back to me and kept talking. That's when Brad stated that he was gonna kill [Redacted]. [Redacted] replied again dude I don't know what your problem is nor what you are talking about. Then Brad said I should just cut your throat. Then Brad said (I'm special forces and I'll just kill you. I should just gut you.) At that point is when Brad pulled his knife out and said I'm gonna slice your throat. When that was done and said [Redacted] grabbed a hold of Brad and I came over the bar and grabbed a hold of Brad as well so we could pull him out of the bar. When Aaron wrapped Brad's arms up to pull Brad outside [Redacted] got cut with Brad's knife. While pulling Brad out of the bar he is still yelling

I know that I am not under arrest. I voluntarily and freely furnish this statement which is true and correct to the best of my knowledge.

After we were both treated we went back  
to the Beulon so I could work and close  
the bar. By the time I got back to the bar  
[redacted] had Brad's knife.
