

On 09/08/2014 | Deputy Jeffrey Stroehlein UC31 received a call from the Anna Police Department. Captain Elliot of the Anna Fire Department stated that he received a call from Officer Huttieson of the Marion Police Department stating that Michael T Specht had been in

Marion earlier in the day and had made some threats and may possibly need to be taken to the hospital for a psychological evaluation. Specht resides in Anna but Elliot requested the Sheriff's Office handle the call because according to him, Officer Jason Leek did not want anything to do with the call.

I called Huttleson on the number at [redacted] and he told me that he received information that Specht had made threats against his former land lord stating he was going to cut tires, burn their house down and kill their 4 year old grandchild. Huttleson said Specht used to reside in Marion and he was very familiar with him stating this was not uncommon behavior for him. He said that if I got Specht to the Emergency Room and had staff contact him he would further explain the situation to the ER staff.

I then went to 314 S Main Street in Anna and spoke with Specht. I told him the situation and he denied making any such threats. I asked him if he was having any mental health issues and he said no. I asked him if he would be willing to come with me to the Union County Emergency Room for a psychological evaluation and he said yes if it would clear up the problem. I then transported Specht to the Union County Emergency Room and he was evaluated and released. I then transported Specht back to his residence on Main Street.

I have nothing further to report at this time.
