

Witness Aggravated Battery Pending Investigation

On January 08,2014 I,Deputy Kenneth Taylor,responded to a report of a fight on the grounds of Choate Mental Health near Willow Hall. Upon my arrival Officers Brian Watkins,Tim Smith of Anna Police Department and Cobden Officer B J Hale had the parties involved separated. The altercation occurred in the parking lot in front of Willow Hall,Department of Human Service. Several D.H.S. employees witnessed the altercation and intervened attempting to break it up.

I observed a Hispanic male with blood on his face which was later identified as Angel Salazar. Mr Salazar was unable to speak English. Conservation Police Officer Steve Vasicek arrived on scene and was able to speak with Salazar. Officer Vasicek was able to ascertain from Salazar that the other two Hispanic males at the scene had hit him several times and one of the hit him with what he believed to be a pair of pliers. Salazar stated that taller of the two men was the one that had the pliers. This male subject was later identified as Jose Abarca . Officers on scene searched the area and the truck but were unable to locate the pliers or any other similar object. There was also a Hispanic female which stated she could speak English,she identified herself as Alma Queriapa. Alma advised that Salazar was her boyfriend and that they had came to the D.H.S. office to pickup some information. As they were returning to their vehicle she saw her husband Jose Abarca and father Melchor Campos in the parking lot near her vehicle. She stated that she told Salazar to go back inside but before he was able to do so her husband and father approached them. Alma said that both her husband and father started hitting Salazar, she tried to stop them but wasn't able to. She also advised that they attempted to get her in their vehicle but she did not want to go with them. This is when some of the D.H.S. employees intervened and the police arrived. Alma advised that she is still married and lives with her husband(Jose). Alma provided the attached written voluntary statement.

I interviewed the four D.H.S. employees at this time and each of them advised the following. Alma had came to their office with a unknown male (Angel Salazar) and as they were leaving a white truck pulled in the parking lot. Two males exited this truck and walk toward Salazar and Alma. They advised that Salazar started backing up as the two males approached him but was not able to get away from them before they began hitting him. They advised that one of the

men had some type of metal object in his hand and was striking Salazar with it. They described the man with the object to be the taller of the two which would have been Alma's husband, Jose Abarca. They also stated that the two men forced Alma into the truck and that she was struggling trying to get away from them. D.H.S. employees Blackburn and Murray approached the men advising them if she did not want to go with them willingly she did not have to. Each of the employees provided the attached written statements.

Melchor Campos and Jose Abarca were taken into custody at this time for Aggravated Battery. Once at the Union County Sheriff's Office I interviewed them. Jose advised that he did not speak or understand English so the interview was ended at this time. Melchor stated that he could speak and understand English. I advised him of his Miranda and he stated that he understood them and was willing to speak to me at this time. Signed waiver is attached. Melchor stated that he and Jose had gone to D.H.S. office because they knew Alma had gone there and suspected that Salazar was with her. When they saw them there they exited the truck and approached Salazar. He stated that they both started hitting him and at one point when Salazar was on the ground he started kicking him. This interview was recorded and will be marked as exhibit 1.

Photographs were taken of Salazar's injuries and are marked as exhibit 2.
