Please consider this our response to your attached Freedom of Information Act request, received via email on August 25, 2016 and summarized below:

Any and all police reports maintained by Union County Sheriff's Department related to Roderick Lynn Hileman, DOB: XX/XX/XX from January, 2010 to the present

Thank you for granting us extended time to respond given the volume of responsive records and the need for reviewing them for information exempt from release.

Please find attached all responsive records in our possession or custody. There was an arrest of Mr. Hileman on July 13, 2012 for violation of an order of protection for which we were unable to locate a report.

Please note that the following redactions have been made:

- Documents generated in the Law Enforcement Agencies Database System (LEADS) must be kept confidential in accordance with Title 20 Part 1240 Section 1240.50 of the Illinois General Assembly Administrative Code (20 Ill. Admin. Code 1240.50). As such, any information specific to LEADS is exempt from release.
- The name of the victims are exempted under Section 7(1)(c) of FOIA (5 ILCS 140/7(1)(c)) as approved by the Office of the Attorney General in pre-authorization letter 2011 PAC 12171.
- We feel that photographs of a victim that could be used to identify him are not in the public interest per Section 7(1)(c) of FOIA (5 ILCS 140/7(1)(c)), therefore those photos have been redacted.

Report for Incident 2012-003018

On 6-9-12 at approximately 1824 hrs, a call was placed to the Union County Sheriff's Office stating that Rod Hileman was at his dads house and is fighting and hitting people. Upon arrival to [REDACTED] it was noticed that all parties were separated. I then approached a man that was bleeding from the mouth and asked him what had happened.

The man was identified as [REDACTED] from [REDACTED] along with his wife [REDACTED]. [REDACTED] stated that Rod hit him in the mouth two times causing the damage that I could see. I then asked him how it come about. [REDACTED] stated that Rod was threatening and cursing his dad [REDACTED], so he told him to leave him alone. Rod then approached him by his ([REDACTED]'s) vehicle and got into his face. He stated that Rod then struck him twice causing a tooth to go through his lip.

[REDACTED] (Father to Rod) also agreed with the account given by [REDACTED]. [REDACTED] stated that he seen it happen and that he was not going to lie about any of the accounts. [REDACTED] stated that Rod was angry at him and was going off about tools and just went up and punched [REDACTED] in the mouth twice because [REDACTED] told Rod to stop talking to his brother the way he does, and was tired of the way he treated him.

I then went and spoke to Rod Hileman. Rod stated that he did not do anything wrong, and that he was just defending himself. I asked him what he was talking about. Rod stated that [REDACTED] came up on him and was poking him in the face with his finger. He stated that at one point [REDACTED] poked him in the eye. He stated that he told [REDACTED] to back off several time but he would not. Rod stated that he continued to get poked in the face while [REDACTED] was yelling at him so he slapped him in the face. Rod stated that [REDACTED] stood up and acted like he was going to do something so he hit him again a little harder.

Rod was taken into custody due to having Two warrants for his arrest and [REDACTED] signing a complaint against Rod for Battery. Rod was transported directly to Jackson County Jail.

Report for Incident 2013-005914, 911 Hang Up, document created on 12/29/2013 @ 02:59:21

On 12/28/2013, at approximately 11:20 p.m., I, Deputy Robert McGee, was told by dispatch, to go to [REDACTED]. Dispatch had received a 9-1-1 call, from a male. The male would not say why he called 9-1-1. This address is where four trailers are located, that Roderick L. Hileman, [REDACTED] and [REDACTED] live. Dispatch said they could not determine exactly what trailer the call was coming from.

I contacted Deputy Larry Clover to assist me. Trooper Brian Watkins, from the Illinois State Police also assisted me.

While we were on our way to [REDACTED], dispatch told me they had received another 9-1-1 call from [REDACTED]. This call was from a female. The female said, we need the police, then the female hung the phone up.

I arrived at [REDACTED], at approximately 11:38 p.m.. Trooper Watkins, and Deputy Clover were with me.

When I arrived at [REDACTED], I saw someone standing in the driveway, at the top of the hill. This person was standing by [REDACTED]. This mobile home, was the only mobile home, that had any lights on. This is the mobile home, that [REDACTED] lives in. There was a maroon 1999 Chevrolet pickup sitting in the driveway. The Chevrolet had Illinois license plate number [REDACTED].

As I approached the person in the driveway, I recognized him as being Roderick (Rod) L. Hileman.

Rod asked me, why the fuck are you here? I told Rod, we received two 9-1-1 calls, from two different people. Rod said, I didn't call you. I asked Rod, who else is here? Rod said nobody. After a couple of minutes of talking, Rod told me there was someone in the house. I told Rod I needed to go speak with the people. Rod told me, you can't go near that fucking house without a warrant. I repeatedly told Rod, I had to check, to make sure nobody was hurt. Rod continued to tell me I could not go near the house without a warrant. I started walking towards the back door of the mobile home. As I approached the back porch, I could see a male, later identified as Daniel S. Barnhart, laying on the porch. Daniel had blood coming from his mouth, and nose. Daniel had blood on his clothes. Daniel appeared to be unconscious. After a minute, Daniel looked up at me. Daniel either would not talk, or could not talk. I

asked Rod, what happened to Daniel? Rod said, I knocked him the fuck out. I repeatedly asked Daniel, what happened to you? Daniel would never tell me. I told Rod I needed to check inside the house, to make sure nobody else was injured. Rod told me, I will whip the fuck out of all of you if you try to go in that house. Rod said, if you don't have a warrant, you can't go in there. I told Rod, we received a 9-1-1 call from a male, and a female, we need to check to make sure no one else is injured. Rod continued threatening to kick all our asses if we attempted to enter the mobile home. I asked Rod, where is Kelsey? Rod said, she left just before you got here.

I am familiar with all of the [REDACTED]. In the past, [REDACTED], has had an order of protection against Rod Hileman. [REDACTED] and Rod have been known to fight each other. I was aware that [REDACTED]'s daughter, [REDACTED], drives the Chevrolet in the driveway.

I had dispatch send Officer Nathan Smith, from the Jonesboro Police Department, to my location to assist. When Officer Smith arrived, I asked Officer Smith to stay by the front door.

I went back to where Trooper Watkins, Deputy Clover, Rod Hileman, and Daniel Barnhart were. Rod had walked over to the back porch, and picked up a shovel. Rod was walking towards us, with the shovel in his hands. I pointed my taser at Rod, and ordered Rod to drop the shovel. Rod stopped, and after a few seconds, dropped the shovel. For officer safety, I told Daniel, to place his hands behind his back. Daniel asked why? I told Daniel, for officer safety, I want to place handcuffs on you. Rod stepped in between Daniel and I. Rod said, why are you arresting him? I again pointed my taser at Rod, and told Rod to move out of my way. I had to tell Rod several times, to move out of my way. Daniel started telling Rod, get em, get em. Rod eventually moved out of my way. Daniel refused to place his hands behind his back. After several orders, from myself, Deputy Clover, and Trooper Watkins, Daniel placed his hands behind his back. Daniel grabbed my right hand, as I was attempting to place handcuffs on him. I was eventually able to get my hand free from Daniel, and place handcuffs on Daniel. After Daniel was secured, I told Rod to place his hands behind his back. Rod asked why? I told Rod, for officer safety, I want to place handcuffs on you. Rod refused to comply. I told Rod if he did not comply, I would place him under arrest. Rod asked, what can you arrest me for? I told Rod, for assault, and for obstructing a police officer. Rod still refused to comply. Rod said we could not go in the house without a warrant. I told Rod, because of Daniels injuries, and because a female and a male called 9-1-1, I needed to check to see if anyone else was injured. After several minutes, Rod complied, and I was able to place handcuffs on Rod.

Deputy Clover stayed with Daniel, and Rod. Trooper Watkins and I went through the mobile home, to make sure no one else was injured. We did not locate anyone.

I went back outside, to speak with Rod and Daniel. Daniel would not tell me what happened to him. Daniel would say, I will fuck you up, or just "fuck you". Daniel was having trouble speaking. Because of Daniel's injuries, I had dispatch send an ambulance for Daniel. After several minutes, Rod calmed down. I removed the handcuffs from Rod. Daniel continued to cuss at me, and would spit blood at me. Several times, Rod would say, I'll kick his ass again. (referring to Daniel)

After the ambulance arrived, Daniel refused to talk to the EMT's.

Because of Daniels physical condition, I did not feel it was safe to leave Daniel. I was also concerned there would be another fight, between Daniel and Rod.

At approximately 1:15 a.m., I told Daniel I was placing him under arrest. I transported Daniel to the Union County Sheriffs Office.

Daniel was photographed while sitting in my car, and in the holding cell. (see attached photographs)

I placed Daniel in a holding cell. Daniel fell asleep, almost immediately.

I issued Daniel two non-traffic citations:

1. citation number 003783, for aggravated assault
2. citation number 003784, for resisting a peace officer

At approximately 5:15 a.m., Daniel woke up. I went in to the holding cell, and spoke with Daniel. I asked Daniel, will you tell me where you live? Daniel said yes, [REDACTED].

I told Daniel I would take him home. I gave Daniel his citations, and told Daniel about his court date. I gave Daniel a notice to appear.

I transported Daniel to [REDACTED]. On the way to [REDACTED], I asked Daniel, do you know what happened to you? Daniel said no. I told Daniel, Rod said he did this to you. Daniel said, I will never tell.

I am requesting the Union County States Attorney, review this report, for possible charges.





On March 19th 2015, at approximately 5:44 PM, I (Deputy Tim Goodman) was dispatched to [REDACTED] reference a possible fight. I arrived on scene shortly after along with Deputy Eric Ralls and Anna Officer Tim Smith.

Upon arriving on scene, police spoke with Rodrick L Hileman (w/m DOB [REDACTED]). Rod stated he and his father had been arguing and cussing each other. Rod stated no battery occurred and he just wanted to leave to avoid any further confrontation. Rod entered Deputy Eric Ralls patrol vehicle for Ralls to provide him transportation to another location.

While Ralls was transporting Rod, I went to speak with Rod's father [REDACTED] (w/m DOB [REDACTED]). The tip of [REDACTED]'s nose was bleeding a small amount. [REDACTED] stated Rod had been pointing at [REDACTED] and scratched his nose while they had been arguing. [REDACTED] stated he would sign a complaint against Rod.

I then radioed Ralls to transport Rod to the Union County Sheriff's Office to be questioned.

[REDACTED] signed a complaint and filled out a written statement. I then took photographs of [REDACTED]'s scratched nose and have attached the pictures to this report.

I then went to the UCSO to interview Rod. Rod was read his Miranda rights and then he voluntarily signed the form stating he would waive his Miranda rights. Rod stated he and his dad had only been yelling at each other. Rod stated he didn't hurt [REDACTED] and would never lay a hand on him. Rod then stated [REDACTED]'s nose had been cut for several days and was on blood thinners which caused him to bleed often.

After speaking with [REDACTED] and Rod, I believed the injury which may have occurred could have been accidental or not caused by Rod. I then released Rod and explained to him I would type this report and send it to the State's Attorney's Office to determine whether to charge Rod.

I met with Rod, and he asked who I was. He then recognized me and said it's a good thing you're not [REDACTED] or I'd have a rifle for you, I'm not getting my ass beat by him again. I then explained I had a signed complaint. He stated he had not done anything. He also stated that he did not have a rifle, and never threatened anyone. I told him he threatened [REDACTED] when I got there.

I then placed Rod in handcuffs checking for proper fit and double locked them. I then transported Rod to the Sheriff's Office without incident.

Nothing further at this time.

[REDACTED] and [REDACTED] stated that Rod was out of control hearing noises and voices at night. Telling [REDACTED] that the voices are hiding under his trailer.

Rod lives with his grandmother [REDACTED] DOB [REDACTED]. [REDACTED] is afraid that his Grandmother who just came home from the Doctor 02-03-2010 with pneumonia is not getting the proper care she needs. [REDACTED] is suppose to be getting 2 breathing treatments a day in which [REDACTED] has helped with in the past. Rod will not allow [REDACTED] or [REDACTED] near the trailer. [REDACTED] who has helped dispense [REDACTED]'s medicines in the past observed the pill bottles almost full Tuesday when the dropped [REDACTED] off from her doctors appointment.

On several occasions in the past Rod has threatened to kill both he and [REDACTED]. Rod has told [REDACTED] if he caught her outside he would kill her and get rid of her for good.

Both [REDACTED] and [REDACTED] feel that Rod has something mentally wrong with him and that he needs help.

DETAILS OF OFFENSE

On 1-17-13 at approximately 1600 hrs, Myself and Deputy John Theriac were dispatched to [REDACTED] to speak with Roderick L. Hileman in reference to it being reported that he has been handling firearms. Upon arrival to the residence, we approached the rear door of the residence. Rod came to the door and spoke with both of us.

Rod stated that he had not been firing or handling any firearms at all and stated "let them prove that I have". Rod then stated that the only problem that he has is that [REDACTED] ([REDACTED]) owes him money and that he wanted his money from her. I stated to Rod that we would go over and speak with her about the situation.

We then went to [REDACTED] and spoke with [REDACTED]. [REDACTED] stated that the amount Rod is talking about was not correct and that it had to do with a birthday party. She then stated that Rod needs some help and that he is seeing things. She stated that he came up to her residence with a Shotgun on the 15th stating that people were on the property and went into the woods. She stated that Rod went to the bathroom in the residence, so she unloaded the shotgun without him knowing it. Deputy Theriac asked [REDACTED] if she would fill out a voluntary statement on what she had just discussed. She agreed to do so, and handed me two shot shotgun shells that were 12 gauge 3 inch high brass.

With the information provided by [REDACTED], it was decided to take Roderick Hileman into custody. As we were preparing to go back to [REDACTED], [REDACTED] father to Rod approached my vehicle and stated that he believed Rod may have a weapon on him. I asked what made him think that. [REDACTED] said Rod told his mother that he was not going back to Jail and that she may want to go into the house because she did not want to see this. [REDACTED] went on to say that it appeared that there was a bulge in his front sweater pocket and he did not know what it was. [REDACTED] stated that Rod doesn't need jail, he needs help mental help.

As we approached the residence, Rod was noticed going behind the house and out of sight. After exiting the vehicles Rod was noticed in the woodline behind the residence. As we began to walk toward him, Rod stated that he did not want all of the guys walking up to him and that he was not going back to jail. Rod Stated that he would talk to me (Deputy Clover). I then

approached Rod and explained the situation to him. Rod was stating that it was "bullshit" and that no one seen him with any guns. I stated to him that I can only go off of what I am told and that we can try to get it cleared up at the County. Rod was taken into custody without incident and had no weapons on his person. Rod was then transported to the Sheriffs Office.

Later that evening I spoke with [REDACTED] asking him what kind of shotguns he owned. [REDACTED] stated that the shotgun that Rod had been shooting is a Model 12 Winchester 12 gauge with a 2 and 3/4 inch chamber. I asked [REDACTED] if he had any 3 inch shells at his residence, and at first he stated no because his gun is 2 and 3/4 inch but after he looked it was noticed that he had a box of Western Super X shells that he stated were reloads and given to him. The box was full when he received it but now only seven remain. The shotgun was checked to see if it would actually chamber 3 inch shells, and it would.

[REDACTED] stated that on the 16th he had went to his son [REDACTED]'s residence and retrieved his shotgun that [REDACTED] stated Rod left up there along with two five shells. Then took it back to his residence. [REDACTED] agreed to give a statement on what was discussed
