- (1) We are denying your request for these records as they relate to a pending case or cases and as such disclosure would create a substantial likelihood that a person will be deprived of a fair trial or an impartial hearing pursuant to Section 7(1)(d)(iii) of FOIA (5 ILCS 140/7(1)(d)(iii)). Additionally, pursuant to Supreme Court Rule 415(c) (134 Ill. 2d R. 415(c)) materials such as those responsive to this request shall remain in the exclusive custody of the attorneys they are furnished to under the Regulations of Discovery.
- (2) Chief Information Officer Rollie Hawk and State's Attorney Tyler Edmonds are the persons responsible for this denial.
