Please consider this our response to your attached Freedom of Information Act request, received via postal mail on September 27, 2017 and summarized below:

Records regarding Kyle A. Wills from January 1, 2015 to the present.

We are denying your request. Please be advised of the following:

- (1) We are denying your request for these records as they relate to a pending case or cases and as such disclosure would create a substantial likelihood that a person will be deprived of a fair trial or an impartial hearing pursuant to Section 7(1)(d)(iii) of FOIA (5 ILCS 140/7(1)(d)(iii)). Additionally, pursuant to Supreme Court Rule 415(c) (134 Ill. 2d R. 415(c)) materials such as those responsive to this request shall remain in the exclusive custody of the attorneys they are furnished to under the Regulations of Discovery.
- (2) Chief Information Officer Rollie Hawk and State's Attorney Tyler Edmonds are the persons responsible for this denial.

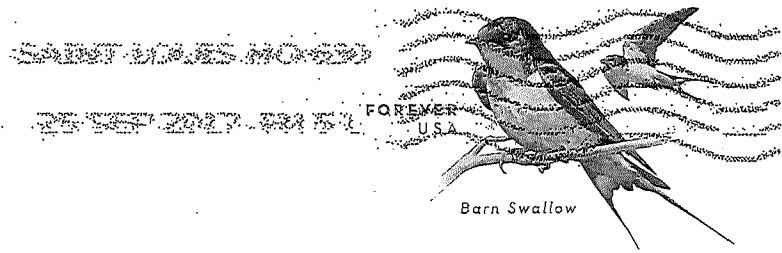
