The Union County Board of Commissioners met for a special meeting in the Union County Courthouse Community Room at 1:32 p.m. Chairman Richard Cunningham called the meeting to order and roll call was taken by County Clerk Terry Bartruff with Richard Cunningham, Max Miller, and Bobby Toler Jr. present.

The state budget concerns were discussed. Union County relies on 12% of the county's budget coming from the state and 70 % of the highway department budget coming from the state MFT.

There were concerns discussed about what would happen if a state budget was not passed soon and if state funding would be disbursed from the beginning of the state fiscal year or from the date when the budget was passed.

Chairman Cunningham praised the elected and appointed officials for working with the commissioners in keeping expenses down during these unknown times for the state budget. He stated that unplanned increases in other state revenue and other funds from the state has helped in the current situation.

Ms. Moreland asked what those funds were.

Mr. Cunningham Stated that they were from unanticipated increases in income tax and sales tax were the two main revenues he was talking about.






