A discussion concerning the City of Anna and other county municipalities in regards to dispatching services being provided by Union County ensued.


A motion was made by Danny Hartline and seconded by Max Miller to adjourn.

Chairman Don Denny: All those in favor say aye opposed none. Motion carried.






