

NOTICE OF 2016 REAL ESTATE ASSESSMENT CHANGES

The following is a list of all Real Estate assessments for townships other than those listed in the quadrennial publication list. All assessed values are subject to revision by the Board of Review, Local, and State Equalization.

This publication, which is made in accordance with section 12-10 of the Property Tax Code, serves as public notice to property owners that the median level of assessment in Union county for 2016 payable 2017 is 32.40 based on three years of sales transactions from 2013-2015. The statutory median level is 33.33 of fair cash value.

You may check the accuracy of your assessment by dividing your assessment by the median level of assessment. The resulting value should equal the estimated fair market value of the property. If the resulting value is greater than the estimated fair cash value of your property, you may be over-assessed.

Property owners who consider their property incorrectly assessed may file a complaint in writing with the Union County Board of Review in accordance with section 16-55 of the Property Tax Code. All complaints must be filed with the Supervisor of Assessments Office within 30 days following the date of this publication at 309 W. Market St., Rm. 128, Jonesboro, Illinois 62952.
