

**COUNTY OF UNION,

**COMBINED ANNUAL BUDGET AND APPROPRIATION
ORDINANCE FOR THE FISCAL YEAR COMMENCING ON
DECEMBER 1, 2010 AND ENDING ON NOVEMBER 30, 2011**

WHEREAS, pursuant to 55 ILCS 5/6-1001, a board of county commissioners shall adopt each year an annual budget for the succeeding fiscal year; and

WHEREAS, pursuant to 55 ILCS 5/6-1001, such annual budget shall cover such a fiscal period of one year to be determined by the board of county commissioners; and

WHEREAS, the Board of County Commissioners of the County of Union, Illinois has considered and determined the amounts of monies estimated and deemed necessary to meet and defray all the legal liabilities and necessary expenses to be incurred by November 30, 2010, and has further listed and specified detailed statements of budgeted itemized county expenditures in the attached recommended budgets; and

**NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF
COMMISSIONERS OF THE COUNTY OF UNION, ILLINOIS, AS FOLLOWS:**

SECTION 1: The 2010-2011 Fiscal Year for the County of Union, Illinois shall begin on December 1, 2010 and end on November 30, 2011.

SECTION 2: The attached budget is adopted for the County of Union, Illinois for the 2010-2011 Fiscal Year and is made a part of, and incorporated in, this ordinance.
