ORDINANCE AMENDING THE LIQUOR CONTROL ORDINANCE

WHEREAS, the Illinois Liquor Control Act, 235 ILCS 5/1-1 *et seq.*, authorizes a county to regulate the sale of alcoholic liquor within its territory outside the corporate limits of any city, village or incorporated town; and

WHEREAS, the Board of Commissioners of the County of Union, Illinois has previously adopted a Liquor Control Ordinance, Ordinance No. 2009-11, an Ordinance Amending the Liquor Control Ordinance, Ordinance No. 2009-13 and an Ordinance Amending the Liquor Control Ordinance, Ordinance No. 2010-11; and

WHEREAS, the Board of Commissioners of the County of Union, Illinois finds that the health, safety and welfare of the People of the County of Union, Illinois will be protected and temperance in consumption of alcoholic liquors will be fostered and promoted by amending the Liquor Control Ordinance.

NOW, THEREFORE, BE IT ORDAINED by the Board of Commissioners of the County of Union, Illinois as follows:


SECTION 1: The Liquor Control Ordinance, Ordinance No. 2009-11, as amended, is hereby amended by changing Section \_\_\_-4-1 as follows:

\_\_\_-4-1 Hours of Operation.

- (a) It shall be unlawful to sell or furnish alcoholic liquor at retail between the hours of ~~twelve o'clock (12:00) A.M. midnight~~ twelve thirty (12:30) A.M. and six o'clock (6:00) A.M. on any day of the week.
- (b) It shall be unlawful to keep open for business, to admit the public, to permit the public to remain within, or to permit the consumption of alcoholic liquor by any person in or upon the licensed premises in which alcoholic liquor is sold at retail between the hours of ~~hours of twelve thirty (12:30) A.M.~~ one o'clock (1:00) A.M. and six o'clock (6:00) A.M. on any day of the week; provided, however, that any holder of a Class B, C, D or F license may remain open during between the hours of ~~twelve thirty (12:30) A.M.~~ one o'clock (1:00) A.M. and six o'clock (6:00) A.M. for purposes other than the sale of alcoholic liquor.

SECTION 2: This ordinance shall be in effect upon its passage, approval and publication as provided by law.


