

# UNION COUNTY STATE OF ILLINOIS RESOLUTION OF TAX LEVIES

A resolution levying taxes for the uses and purposes hereinafter set forth for Union County, State of Illinois for the fiscal year beginning December 1, 2008 and ending November 30, 2009.

Wherein, the Board of County Commissioners of Union County, have determined that it is necessary to raise the sum of \$2,446,550.00 for the following purposes set forth below.


Now therefore, be it resolved that there be and hereby is levied on 2008 assessed values to be collected by general taxation and the County Clerk hereby directed to extend tax upon all real, personal and mixed property of the County of Union in the State of Illinois, subject to taxation as the same is assessed and equalized for taxation for the State and County purposed for the fiscal year beginning the (1<sup>st</sup>) first day of December, 2008 and ending the 30<sup>th</sup> day of November, 2009 for the purposes of defraying current expense for said period and payment of unfunded indebtedness for unpaid claims of said County at rates not to exceed rates specified below.



Union County has 2 (two) bonds that has not been paid in full.






# PROPERTY TAX EXTENSION LIMITATION LAW


# COMPLIANCE WITH TRUTH AND TAXATION ACT
