WHEREAS, pursuant to 705 ILCS 105/27.3, a county board shall fix the compensation of the circuit clerk; and

WHEREAS, pursuant to 50 ILCS 145/2, the compensation of elected officers of units of local government, which compensation is to be fixed by that unit of local government, shall be fixed at least 180 days before the beginning of the terms of the officers whose compensation is to be fixed; and

WHEREAS, the terms of the Union County Clerk, Union County Treasurer, Union County Sheriff and one Union County Commissioner begin December 1, 2010; and

WHEREAS, the compensation of a circuit clerk may be fixed at any time; and

WHEREAS, Board of Commissioners of the County of Union, Illimois finds that it is necessary to set the compensation for certain elected officials for the period beginning December 1, 2010.

NOW, THEREFORE BE IT RESOLVED, by the Board of Commissioners of the County of Union, Illinois as follows:
