**RESOLUTION SETTING CERTAIN PROPERTY TAX LEVIES FOR THE FISCAL  
YEAR COMMENCING ON DECEMBER 1, 2010 AND ENDING ON NOVEMBER 30,  
2011**

**WHEREAS**, pursuant to 35 ILCS 200/18-10, a county board of commissioners shall certify to the county clerk annually, on or before the last Tuesday in December the amounts of county property taxes to be levied for all purposes; and

**WHEREAS**, the Board of County Commissioners of the County of Union, Illinois has considered and determined the necessary amounts of county taxes to be levied for all purposes; and



18-60 THROUGH 18-85 OF THE PROPERTY TAX CODE**


