**RESOLUTION TO APPROVE COMPENSATION FOR CERTAIN ELECTED OFFICIALS**

**WHEREAS**, pursuant to 55 ILCS 5/4-6001, a county board shall fix the compensation of the county coroner; and

**WHEREAS**, pursuant to 55 ILCS 5/4-9001, a county board shall fix the compensation of county commissioners; and

**WHEREAS**, pursuant to 50 ILCS 145/2, the compensation of elected officers of units of local government, which compensation is to be fixed by that unit of local government, shall be fixed at least 180 days before the beginning of the terms of the officers whose compensation is to be fixed; and

**WHEREAS**, the terms of the Union Coroner and three Union County Commissioners begin December 1, 2012; and

**WHEREAS**, Board of Commissioners of the County of Union, Illinois finds that it is necessary to set the compensation for certain elected officials for the period beginning December 1, 2012.

**NOW, THEREFORE BE IT RESOLVED**, by the Board of Commissioners of the County of Union, Illinois as follows:

The annual salary for the Union County Coroner shall be as follows:

For the Fiscal Year Beginning December 1, 2012	\$14,000
For the Fiscal Year Beginning December 1, 2013	\$14,000
For the Fiscal Year Beginning December 1, 2014	\$14,000
For the Fiscal Year Beginning December 1, 2015	\$14,000

The annual salary for a County Commissioner elected at the 2012 General Election to the seat designated as Seat A shall be as follows:

For the Fiscal Year Beginning December 1, 2012	\$ 8,000
For the Fiscal Year Beginning December 1, 2013	\$ 8,000
For the Fiscal Year Beginning December 1, 2014	\$ 8,000
For the Fiscal Year Beginning December 1, 2015	\$ 8,000
For the Fiscal Year Beginning December 1, 2016	\$ 8,000
For the Fiscal Year Beginning December 1, 2017	\$ 8,000

The annual salary for a County Commissioner elected at the 2012 General Election to the seat designated as Seat D shall be as follows:


For the Fiscal Year Beginning December 1, 2012	\$ 8,000


