

**COUNTY OF UNION,

RESOLUTION TO APPROVE COMPENSATION FOR CERTAIN ELECTED OFFICIALS

WHEREAS, pursuant to 55 ILCS 5/4-6001, a county board shall fix the compensation of the county treasurer and county clerk; and

WHEREAS, pursuant to 55 ILCS 5/4-6003, a county board shall fix the compensation of the sheriff; and

WHEREAS, pursuant to 705 ILCS 105/27.3, a county board shall fix the compensation of the circuit clerk; and

WHEREAS, pursuant to 50 ILCS 145/2, the compensation of elected officers of units of local government, which compensation is to be fixed by that unit of local government, shall be fixed at least 180 days before the beginning of the terms of the officers whose compensation is to be fixed; and

WHEREAS, the terms of the Union County Clerk, Union County Treasurer and Union County Sheriff begin December 1, 2014; and

WHEREAS, the compensation of a circuit clerk may be fixed at any time; and

WHEREAS, Board of Commissioners of the County of Union, Illinois finds that it is necessary to set the compensation for certain elected officials for the period beginning December 1, 2014.

NOW, THEREFORE BE IT RESOLVED, by the Board of Commissioners of the County of Union, Illinois as follows:

The annual salary for the Union County Clerk shall be as follows:

For the Fiscal Year Beginning December 1, 2014	\$60,000
For the Fiscal Year Beginning December 1, 2015	\$60,000
For the Fiscal Year Beginning December 1, 2016	\$60,000
For the Fiscal Year Beginning December 1, 2017	\$60,000

The annual salary for the Union County Treasurer shall be as follows:

For the Fiscal Year Beginning December 1, 2014	\$60,000
For the Fiscal Year Beginning December 1, 2015	\$60,000
For the Fiscal Year Beginning December 1, 2016	\$60,000
For the Fiscal Year Beginning December 1, 2017	\$60,000


The annual salary for the Union County Sheriff shall be as follows:

For the Fiscal Year Beginning December 1, 2017	\$62,250


The annual salary for the Union County Circuit Clerk shall be as follows:

For the Fiscal Year Beginning December 1, 2015	\$60,000
