**RESOLUTION SETTING CERTAIN PROPERTY TAX LEVIES
FOR THE FISCAL YEAR COMMENCING ON
DECEMBER 1, 2015 AND ENDING ON NOVEMBER 30, 2016**

WHEREAS, pursuant to 35 ILCS 200/18-10, a county board of commissioners shall certify to the county clerk annually, on or before the last Tuesday in December the amounts of county property taxes to be levied for all purposes; and

WHEREAS, the Board of County Commissioners of the County of Union, Illinois has considered and determined the necessary amounts of county taxes to be levied for all purposes; and

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF THE COUNTY OF UNION, ILLINOIS, AS FOLLOWS:



18-60 THROUGH 18-85 OF THE PROPERTY TAX CODE**


