Overview

The County of Union, Illinois (the “County”) is issuing this Request for Proposals (the “RFP”) for group health insurance for more than 50, but less than 100 full time and retired employees of Union County, Illinois. The insurance coverage proposed must meet the minimum requirements as described in Plan Benefits.

Sealed proposals will be received by the County until MONDAY, SEPTEMBER 1, 2014 at 12:00 p.m. in the Union County Clerk’s Office.

The County reserves the right to reject any and all proposals received pursuant to this RFP and to waive or not waive any informalities or irregularities in proposals or proposal procedures, and to accept or further negotiate cost, terms or conditions of any proposal determined by the County to be in the best interests of the County even though not the lowest cost proposal.

Mandatory Requirements and Conditions

A response to this RFP must be **sealed** and must include and/or comply with the following:

- (1) A cover letter designating the name, address and telephone number of the person or persons available for contact concerning the proposal.
- (2) A noted timeline regarding provision of services.

- (3) Current A.M. Best rating.
- (4) References.
- (5) Provider Network Directory, including Physicians, Hospitals and Pharmacies operating with the provider’s network to include Union County, Illinois and surrounding areas within a 50 mile radius of Jonesboro, Illinois.
- (6) Other items the proposer wishes to have considered.

Opening of Bids and Selection of Proposal

Proposals will be opened by the Union County Board of Commissioners at 1 P.M. on Monday, September 1, 2014 at the Commissioner’s Office, Jonesboro, Illinois.

Evaluation Criteria

In determining the most favorable proposal the County shall consider the following:

- (1) Terms of services to be provided.
- (2) Pricing.
- (3) References.
- (4) Prior knowledge or prior dealings of the proposer, as the knowledge or dealings related to official business of the County.
- (5) Any other information and/or factors that the County considers relevant.
